Of the total strength of 40 students per year, 50% are given to government quotas. The Management collects fees as approved by the government of Kerala.

The institution was initially offering a diploma in nursing. But as the years rolled on, its rays had spread to other latitudes in nursing education, such as B.Sc. (Nursing) in 2010. The college is affiliated with the Kerala University of Health Sciences in Trichur and recognized by the Indian Nursing Council and the Kerala Nursing Council. Nursing must keep itself abreast of new findings, enabling it to advance along with other health professionals.

Preamble:

Poyanil College of Nursing is promoted by Poyanil Hospital, Kozhencherry, to cater to this felt and assured need for a quality nursing institution within reach. The College of Nursing has left an indelible mark on bringing up curricula, co-curriculars, and extracurricular activities. These ventures help the students evolve into truly global nursing professionals with high standards and an attitude of dynamicity as gratified citizens.

Introduction

This prospectus contains rules and regulations applicable for selection and admission to the B.Sc. Nursing Course, against sanctioned intake for the academic year 2024–25, with 15% of the college's NRI seats set aside for the dependents of non-resident Indians in the B.Sc. Nursing Course. This prospectus is subject to modification, addition, or deletion as may be deemed necessary by the college and is subject to the judgement of the honorable courts of law or an approving authority.

Number of seats and details of the reservation B.Sc. Nursing

The College has been conducting B.Sc. Nursing Course with an intake of 40 seats. Approved by Kerala Nurses & Midwives Council, Indian Nursing Council and affiliated to Kerala University of Health Sciences. As usual, the College is willing for the seat sharing with the Hon'ble Govt. of Kerala i.e. 20 seats for Merit and Management Quotas respectively. Out of the above 40 seats, 15% seats will be filled up by the candidates from NRI quota 35% of the seats shall be filled up under the Management Quota. The remaining 50% seats are allotted by LBS under merit quota as per the consensual agreement with the Govt. of Kerala. The details of reservation of seats are as follows.

Eligibility for Admission

- Candidates who have passed the Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by any of the board (CBSE, ICSE) with an Aggregate of minimum 50% marks in Physics, Chemistry, Biology and 50% marks in English in the second year only are eligible for admission.
- Admission candidates will be subject to the rules & regulations of the competent authorities from time to time.

Relaxation of Marks

- Candidates belonging to SEBC (Socially and Educationally Backward Classes) in the State of Kerala with a total annual family income up to Rs.6.00 lakhs will have a relaxation of 5% marks. The Scheduled Caste and Scheduled Tribe Candidates in the State of Kerala need 40% marks in the qualifying examination.
- Those candidates claiming relaxation of marks shall produce necessary certificates from the authority concerned. There will be no reservation of seats for SEBC and or SC/ST candidates under the Management quota.
- Eligibility Certificates: Candidates who have passed their qualifying examination from places other than State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

Age

- Applicants should have completed 17 years of age on the 31st December 2025. No relaxation of the minimum age will be allowed. The maximum age limit for admission shall be 35 years.
- Self-attested copy of the relevant page of school record namely SSLC/ICSE/CBSE/ certificate showing the date of birth/copy of the birth certificate should be produced at the time of admission.

Duration:

- Duration of the Programme shall be four years.
- Self-attested copies of certificates/documents to be submitted along with the application include:
 1. The relevant page of SSLC book/equivalent board certificate as proof of age and date of birth.
 2. Certificate and Mark list of Plus Two/12th Std.
 3. In cases where the candidates claim any sort of reservation/preference provided for each College, documents to prove such claims as described in Annexure B by each College.
 4. Certificate in proof of SEBC/OBC/SC/ST status obtained from the Tahsildar concerned.
- While reporting for admission, all the relevant certificates/documents in original as listed below should be submitted to the institution:
 1. Proof of age and date of birth, if applicable.

How toApply

Application for admission to courses of B. Sc Nursing, can be registered only online through a single application. The provision for applying online is available at the website www.poyanilcollegeofnursing.in. The prospectus can also be downloaded from the website.

However, it will not be available by post. Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application.

- If sufficient candidates are not available in the list of applicants, the vacant seats will be filled up by the eligible candidates from the spot allotment.
- Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application.

If any candidate is continuing the course, after the closing of admission as notified by the authority, the candidate has to pay the full fee of the remaining course (4 years). The Collection of liquidated damages shall be as per the final decision of the AFRC or Court of Law.

Special Instructions

a. Ragging: Ragging in any form is strictly prohibited in all member colleges. All the member colleges are committed to abolish ragging on their campuses. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of the law. Also, the student will be expelled from the college as detailed in the law concerned and as per the Honorable Supreme Court of India's directions in this regard.

Rules and Regulations

All the inmates of Poyanil College of Nursing Hostel are expected to abide by following rules and regulations.

GENERAL RULES

- All the inmates of the hostel will be under the control and direction of the Principal and Warden
- During class Hours, the inmates are not allowed to be in the hostel except for taking lunch.
- The inmates should keep their rooms clean and tidy.
- The inmates are not allowed to go to others rooms unnecessarily.
- Nailing on the walls or pasting pictures on the walls inside the rooms are not allowed.
- The inmates are allowed to wash clothes and dry them only in the allotted Place.
- Inmates are not expected to share bed, clothes and other personal items.
- Inmates should maintain silence in the hostel.
- The inmates should ensure that their personal belongings are neatly kept in the places allotted to them.
- The inmates are responsible for their personal belongings including valuable things and the college authorities will not responsible for any theft or lost.
- Inmates should switch off the fans and lights and close the water taps when not in use. The light in the rooms should be put off by 10.30 pm.

- Hostel meetings will be conducted periodically and representatives should attend the meeting and offer their suggestions for better functioning of the hostel.

TIMINGS

- Inmates can use the common study hall for study purposes after 10.30 pm.
- Inmates are expected to follow hostel timings as stated below or as modified by the management from time to time
 - Breakfast - 7.00 am to 7.50 am
 - Lunch - 12.30 noon to 1.00 pm
 - Evening Tea - 4.30 pm to 5.30 pm
 - Dinner - 7.30 pm to 8.15 pm
 - Study time - Morning 5.00 am to 6.00 am
Evening 8.30 pm to 10.30 pm
- All the students are expected to enter the hostel before 6.00 pm unless on duty or left the hostel availing leave.
- Roll call will be taken at 6.00 am and 8.15 pm every day and all inmates should be present except those who are on duty and **w h o** have left the hostel availing leave.

VISITORS

- ❖ **Visitors authorized by the parents can visit the students only on Sundays with permission from the principal and the Warden. Visitors are not permitted to enter the student's rooms. They can meet students in the visiting room.**

OUTPASS

- ❖ Outing is permitted only, with parents. In case of emergency, inmates can obtain permission for out pass from the warden for outgoing. They should return to the hostel before the allowed time.
- ❖ The inmates should sign in the outgoing register kept with the Warden / Security whenever they leave the hostel and while returning back.

USE OF MOBILE PHONES

- ❖ Residents will be allowed to use their mobile phones every day from 4 pm to 6 pm and from 9 am to 4 pm on Sundays.
- ❖ On any other occasion, special permission may be obtained from the Warden for the use of the mobile phone.

HOSTEL FEES

- ❖ A student who wishes to be a resident of the hostel should pay Rs. 24,000/- as hostel establishment fee at the time of admission to the College of Nursing itself.
- ❖ A mess advance of Rs. 2,000/- shall be paid by the resident at entry into the hostel and the same amount shall be refundable on the exit of the hostel.
- ❖ The inmates have to pay the mess bill of Rs. 4000/- on or before the 10th of every subsequent month thereafter. And if not paid in time, a fine of Rs. 50/- per month has to be paid.
- ❖ A resident is eligible for mess fee reduction if only she is absent for more than 10 days and it should be intimated through an advance leave letter authorized by the hostel warden. She is eligible for a refund of 50% reduction from the mess fee of the month for the set period.

- ❖ All inmates making default of room rent, mess fee, or any other dues in connection with her hostel accommodation, for more than two months are liable for vacating the hostel.

RAGGING

- ❖ Ragging in all forms is prohibited. Ragging in any form will be viewed seriously and apart from other statutory proceedings, any inmates found guilty of ragging will be expelled from the hostel immediately on the report of the offense.
- ❖ Unruly behavior, verbal duals, and noisy discussions are strictly prohibited in rooms, dining hall and hostel premises.
- ❖ If any inmates are found disobeying the hostel rules they will be terminated from the hostel.
